In supersession of this deptt. letter of even number dated 23<sup>rd</sup> May, 2012 on the subject cited above and in continuation to this department letter of No. EDN-A-Ka(5)-1/2011-Loose dated 5<sup>th</sup> May, 2012 w.r.t. approval of courses/fees for the session 2012-2013, I am directed to say that as per

provisions of the section 8(a) of the H.P. Private Educational Institutions (Regulatory Commission) Act, 2010 upto one percent fee as assessed by the Regulatory Commission is required to be credited to the fund established vide Act *ibid*. You are, therefore, permitted to charge the fees as would be assessed by the Regulatory Commission for the academic session 2012-13 under section 8(a) of the Act *ibid*, from the students in addition to the fees already fixed/approved by the Government for the academic session 2012-13 in view of the fact that no hike in fee has been allowed by the Govt. for this academic session.

You are, therefore, advised to take further necessary action in the matter accordingly.
